YOU CAN STILL DO THE RIGHT THING FOR THE WELLBEING OF LAMBETH AND SOUTHWARK, FOR THE CULTURE OF LONDON, FOR THE PEOPLE OF THE UK, AND FOR CINEMA LOVERS WORLDWIDE

Museums and charities provide a social, educational and cultural service; they are part of a range of institutions that support our communities and our wellbeing. Their not-for-profit nature makes their services available to all, but it also means they cannot afford high rents. They access grants to fund their work and develop/improve their buildings, but they need to own their buildings to unlock that support. A decade ago the Museum agreed to raise funds to buy its home from SLaM at an agreed independent valuation, at a time of SLaM's choosing. When SLaM then asked us to buy the larger site as a whole, we found a developer-partner. When SLaM rejected our private sector partner and asked for a Housing Association partner, we found one. And now, when SLaM say they will no longer sell to us directly, preferring an open market sale, the Housing Association put in a bid that gives us ownership of our home and the ability to at last be able to access funding. SLaM can decide to sell to us or to someone else who understands the importance of Chaplin's memory; someone who values our heritage, culture and wellbeing work; someone who will work with us to ensure ownership of our home. Or SLaM could just sell to the highest bidder, who is after the most profit – with whom we will not be able to be sustainable. The NHS wrote to SLaM confirming that they do not have to take the highest bid and can consider the widest social value and they are not alone. SLaM, please think of others; please listen to their needs and do the right thing.
